Explanatory notes

<u>A-type representation agreements</u> are agreements in the framework of which monies are exchanged between collective management organisations (CMOs) for usages in their respective territories. <u>B-type representation agreements</u> allow the collecting CMO to retain the monies collected on its own territory to the benefit of rightsholders represented by the other CMO, and to pay them out to the collecting CMO's own rightsholders. Typically, B-type agreements are signed with CMOs in countries the repertoire of which is not frequently used on the Belgian territory and/or with emerging CMOs abroad.

<u>Unilateral agreements</u> cover the representation and payment flow from one CMO to another, but not vice versa. <u>Bilateral agreements</u> cover this flow in both directions.

Representation agreements may exclude certain categories of works (authors) and/or supports (publishers), in which case these are typically covered by a separate mandate agreement between the foreign CMO and a Belgian CMO member of Reprobel.

Mandates in the framework of representation agreements <u>may be limited</u> by the scope of the representation agreement itself, the scope of the (legal) remuneration or licensing scheme in the territory of either CMO and exclusions or opt-outs on behalf of individual rightsholders as applicable.

For <u>Reprobel's repertoire</u> (Belgian authors and publishers), a general <u>opt-out</u> from the Belgian publishing houses Mijade & Alice applies for all usages in the educational sector, and for digital usages in the private and public sector on foreign territories. An similar but overall opt-out applies for all works of <u>Hergé</u> (including but not limited to Tintin), for all usages and all sectors.

<u>Reprography</u> is not limited to paper reproductions but may also include <u>digital</u> re-use of text & image works for the private and public sector (e.g. <u>www.bizili.be</u> for Reprobel). It may, in other countries, also include the publicly funded education and research sector, for which a separate legal licence exists in Belgium.

PLR is Public Lending Rights, a legal licence under Belgian copyright law but not necessarily in other countries.
